For each Order with Qualifying Purchase, Participant will receive one (1) Purchase Entry up to three (3) per day. A "day" is defined as starting at 12:00 a.m. PT and ends at 11:59 p.m. PT.

<u>2) Alternate Means of Entry</u>: To receive one (1) entry without making a purchase ("<u>AMOE Entry</u>", together with Purchase Entries, "<u>Sweepstakes Entries</u>"), visit <u>DealQuestSweepstakes.com</u> (the "<u>AMOE Website</u>"), and complete and submit the online form during the Sweepstakes Period to receive one entry into the Sweepstakes.
